3.	The scope of the LIFe Land domain was proposed as "Define Land related			
	information that would be required to indentify the Land together with the			
	properties of the Land (including ownership and usage) and keeping such			
	information up to date and usable to other stakeholders"			
4.	Committee assessed the listed stakeholders outside the main domain as defined			
	by the consultant and proposed that Occupants and Financial Institutions should			
	be added.			
5.	It was explained by the consultant and decided that data for systems within the			
	domain will be excluded from the scope of this project.

6.	The boundary of the domain was defined as "All Land related information from					
	the point of; creating (or already created) the Land parcel, to capturing the					
	changes in Ownership, use of the Land and any Restrictions placed on the land;					
	this would include the sub-division and amalgamation of land parcels".					
7.	It was decided that properties of the land below the surface (4 feet below the ground) will be outside the boundary.					
8.	mmittee discussed and agreed that there are four (04) Data Categories of					
	information within this boundary.					
	a. Land Parcel Identification Information					
	b. Ownership Information					
	c. Land Usage Information					
	d. Constraints and Restrictions Information
