Decisions/Discussions:

#	Discussion Points
1.	Mr. Harin Gunawardena briefed the committee on the points discussed on the previous meeting.
2.	Committee discussed the proposed data elements for 'Land ParcelIdentification Information'. The data elements were; - Land Parcel Reference Number - Land Parcel Geo Coordinates - Cadastre Ref Number - Land Parcel Address - Boundary Fence Type - Assessment Number - GN Householder's List Number Committee decided that the data element 'Boundary Fence Type' is important only within the domain (is not a sharable data among organizations) and therefore remove from this framework.
3.	Mr. Udayakantha did a brief presentation on the report on 'Land Parcel Reference Number' and its characteristics. It was heighted that there should be a single authority to assign the numbers and to manage it later. He further explained that agreed number by the committee is a combination of coordinates of Longitudes and Latitudes (6 digits for Easting and same for Northing). Ex. XXXXXXXYYYYYY
	It was discussed whether to include a check digit also to validate the accuracy.
4.	 Committee invited the Chief Technology Officer of ICTA (CTO, ICTA), Sanjaya Karunasena for the meeting to get expert idea on the following; Having a check digit for the Land Parcel Reference Number How to interoperate different methods of Geo Coordinates used by different organizations in applications. CTO, ICTA advices on the above was as follows: Check digit will reduce the errors typing the number There could be applications written to interpret the number in to a given standard formula
p)	Number. To make it more readable, committee decided (with the consultation of CTO, ICTA) to use a semicolon to separate the XY coordinates and a hyphen to separate the check digit Ex. XXXXXX:YYYYYYY-C
q)	Mr. Harin Gunawardena explained the Data Category Life Cycle Matrix of this domain. The first of this category was named as "Land Parcel Identification Information Category". The Creators, Owners, Users, Keepers/Shares, Modifiers and Authorized to Delete parties were identified for this category.
